Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2023-24 educational progress for Whitehall High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2024-25 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2023-24. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2023-24. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2023-24. Some schools are not identified with any of these labels. In these cases, no label is given.

PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

Whitehall High School students are typically those who either reside within the District's boundaries, or attend through Schools of Choice. Given the building grade alignments with no overlapping grades, students attend the school that provides educational service for the respective age-grade level. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN

In accordance with the Michigan Department of Education's framework for continuous improvement, the staff works together to conduct data-based needs assessments which identify strengths and weaknesses with the instructional program. From the needs assessments, goals

and objectives are developed in a detailed plan that is carried out over the course of 3-5 years. The plans are revised and adjusted annually through the School Improvement process. Whitehall High School continues to teach core academic skills while also focusing on non-academic skills and community involvement to prepare students to be 100% community ready when they leave the district.
